- I. Meeting was called to order at 6:00 p.m.

- III. Roll Call for Quorum Present were, Supervisor Fremarek, and Trustees Knight, Starr, Kraulidis and Nelson. Also attending were, Assessor Kljaich, Highway Commissioner Marland, Tax Collector Bernicky, Clerk Michelle Smith and Administrator Chuck Willard.
- IV. Approval of the Agenda Motion made to approve agenda by Trustee Starr; seconded by Trustee Kraulidis. Voice vote taken. All ayes. Motion carried.
- V. Approval of Minutes
  - A. Motion to approve minutes from the January 9th .2019 Regular Board Meeting, made by Trustee Nelson; seconded by Trustee Starr. Voice vote taken. All ayes. Motion carried.
- VI. Public Comments: Joan Quinn thanked the Highway Commissioner for a job well done with snow and brush removal. She said she appreciated all their hard work.
- VII. Donation Requests: Shawn Marconi from the Will-Grundy Medical Clinic spoke to the board about the needs of the clinic with regards to the medical needs of the 1000 patients they provide care to. She has asked that provide some sort of financial assistance. They board voted to engage in a contact for up to \$1000 to help provide the medical care as needed. Voice vote taken. All Ayes, Motion carried.

#### X. New Business

- A. Supervisor Fremarek asked that the Township terminate the Giving Tree Donor Wall program and refund donors due to the lack of interest. Motion was made by Trustee Nelson, seconded by Trustee Starr. Voice vote taken. All Ayes. Motion carried.
- B. Supervisor Fremarek asked for a motion to approve the basic Independent Water Lab testing of the Township Building by Aqua Service in the amount of \$967.50.. Motion by Trustee Knight, seconded by Trustee Starr. Roll Call Vote: Nelson-Aye; Starr-Aye; Kraulidis-Aye; Knight-Aye. All Ayes, Motion carried.
- C. Supervisor Fremarek asked for a motion to approve the replacement of a water softener and installation by Aqua service in the amount of \$5391.00. Aqua service provided the lowest quote for the project. Roll call vote: Nelson-Aye; -Knight Aye; Kraulidis-Aye: Starr-Aye, Fremarek-Aye. All ayes. Motion carried.
- D. Supervisor Fremarek asked for a motion to approve the salt service contract with Aqua Service which is need for the new water softener. Service is to fill tank every two-three weeks depending on water usage in the amount of \$128.28 per service call. Roll call vote: Nelson-Aye; -Knight Aye; Kraulidis-Aye: Starr-Aye, Fremarek-Aye. All ayes. Motion carried.
- E. Supervisor Fremarek asked for a motion to approve a LED can light conversion for the Administrator Building with Patriot Lighting in the amount of \$845.00. Many of the lights are not working or need to be updated to LED. There will be an electrical savings and the LED lights will last much longer than traditional bulbs. Motion was made by Trustee Starr and seconded by Trustee Kraulidis. Roll call vote:Trustee Nelson-Aye; -Trustee Knight Aye; Trustee Kraulidis-Aye: Trustee Starr-Aye, Supervisor Fremarek-Aye. All ayes. Motion carried.
- F. Supervisor Fremarek asked for a motion to approve the purchase of a backhoe loader from West Side Tractor for the cemetery in the amount of \$75,531.32. The backhoe currently being used is from 1990 and needed to be replaced. Motion made by Trustee Nelson and seconded by Trustee Starr. Roll call vote: Trustee Kraulidis-Aye; Trustee Starr-Aye; Trustee Knight-Aye; Trustee Nelson-Aye. All Ayes. Motion carried.
- G. Supervisor Fremarek asked for a motion to authorize the purchase from Interiors for Business for office furniture in the amount of \$6016.49. Current furniture is not appropriate for everyday governmental business use. Motion made by Trustee Starr, seconded by Trustee Kraulidis. Roll call vote: Nelson-Aye; -Knight Aye; Kraulidis-Aye: Starr-Aye, Fremarek-Aye. All ayes. Motion carried.
- H. Supervisor Fremarek asked for a motion for the board to authorize the transfer of budget line items. After a brief discussion the board agreed to transfer funds between the various budget line items. Motion made by Trustee Knight, seconded by Trustee Starr. Roll call vote: Nelson-Aye; -Knight Aye; Kraulidis-Aye: Starr-Aye, Fremarek-Aye. All ayes. Motion carried.
- I. Supervisor Fremarek asked for a motion to replace the water heater for the Administrator Building by TMZ Plumbing for the amount of \$4,925.00 which was the lowest bid.

- Current heater is leaking. Roll call vote: Nelson-Aye; -Knight Aye; Kraulidis-Aye: Starr-Aye, Fremarek-Aye. All ayes. Motion carried.
- J. Supervisor Fremarek asked for a motion to approve the Cintas 4 shelf first aid kit and service agreement in the amount of \$202.38 with a service call fee of \$5.63 when needed. The kits are required by law. Motion made by Trustee Kraulidis and seconded by Trustee Nelson. Roll call vote: Nelson-Aye; -Knight Aye; Kraulidis-Aye: Starr-Aye, Fremarek-Aye. All ayes. Motion carried.
- K. Supervisor Fremarek asked for a motion to approve the Shuttle Bus Driver Rules and Qualifications as amended. Trustee Knight asked for some language to be adjusted.
